Notification of Organizational Changes and Personnel Reassignments

2) SKY Perfect JSAT Corporation (as of April 1, 2009)

In order to expedite management decisions by flattening hierarchies while maintaining current services and operations at operating companies, SKY Perfect JSAT Corporation will eliminate divisions and integrate groups. As a result, the current organization of 5 groups and 13 divisions will be consolidated into 6 groups.

- Groups will no longer be the major organizational unit
- The Corporate Planning & Strategy Division and the Human Resource & Purchase Administration Division will be combined to form the Corporate Planning & Strategy Group
- The Finance, Credit & General Affairs Division and the Accounting, Legal & Information Systems Division will be combined to form the Corporate Services Group
- The Broadcasting Business Division will combine with the Content Business Division to form the Broadcasting Business Group
- The Marketing Division and the Customer Service & Communications Division will be combined to form the Marketing Group
- · Sales Division I and Sales Division II will combine to form the Satellite Business Group
- The Satellite Operations Division will combine with the Communications Engineering Division and Broadcast Engineering Division to form the Engineering & Operations Group
