Digital Media &Communication Division will be newly established in the marketing group, as a team specializing in the promotion of SNS-related businesses.


Global & Mobile Business Division of Space & Satellite Business Group will be divided to Global Business Division and Mobile Business Division, for becoming a more specialized organization.

Business Development Division of Space & Satellite Business Group will be renamed Cloud Computing Business Division.



< SKY Perfect JSAT Holdings Inc. Organization Chart (Effective April 1, 2012)>




<SKY Perfect JSAT Corporation Organization Chart (Effective April 1, 2012)>
