- 1) Organizational Changes
- <Corporate Planning & Administration Unit>
- Direct Management Under Unit
- The Compliance Development Division will be established directly under the unit, and a portion of the Corporate Planning Division's current functions will be transferred to this division in order to strengthen the promotion of compliance throughout the Group.
- Corporate Planning & Strategy Group
- •The New Business Promotion Division will be discontinued and functions, such as formulation of new business development strategies and provision of support for company-wide new business projects, will be transferred to the Corporate Planning Division.
- <Media Business Unit>
- Direct Management Under Unit
- •The New Business Promotion Division and the Platform Programming Division under the Business Strategy Department will be discontinued. The LIFE Business Center, which will be responsible for new businesses and new services, will be established directly under the unit, with the LIFE Business Division, and the Data Business Division established under the LIFE Business Center.
- ■Platform Business Group
  - •The Platform Planning Division, which will formulate platform business strategies, will be established. A portion of the duties of the Platform Programming Division will be transferred to this division.
- ■Content Business Group
  - The Channel Operations Division and the Programming Support Division will be reorganized and merged and newly established as the Channel Business Division.
- <Space Business Unit>

To aim for expansion of the business domain to one that goes beyond satellite communications, the Space & Satellite Business Unit will be renamed as the Space Business Unit.

- Direct Management Under Unit
- •The new business promotion functions of the Space Business Unit and the Engineering & Operations Unit will be merged, and the Space Intelligence Development Division will be established as an organization dedicated to such tasks as the development of intelligence businesses that utilize information obtained from space as well as overseeing the low earth orbit satellite communications business, drone operations management, etc.
- ■Global Business Group
  - The Global Business Planning Division will be discontinued, and its functions will be transferred

to the Business Strategy Division and the Engineering & Operations Unit Planning & Coordination Division.

■Satellite Planning & Operations Group

- The Network Engineering Division and the Service Operations Division will be discontinued, and the Teleport Engineering Division, to which the teleport engineering and teleport operation functions have been merged, will be established.
- The Network Operations Division will be established, and a portion of the functions of the Service Operations Division will be transferred to this new division.
- •A portion of the tasks handled by the Network Engineering Division will be transferred to the Satellite Communications Engineering Division, which will be renamed Communications Systems Engineering Division.


