HIKARI, a multiple channel broadcasting service via Radio Frequency (RF) format in areas serviced by NTT West Corporation, along with the completion of registration for the alteration of its broadcasting business through the introduction of cable service in accordance with the Law Concerning Broadcast on Telecommunications Services to the Ministry of Internal Affairs and Communications as noted below.

From June 2008, SKY PerfecTV! HIKARI service area will include all areas in Nagoya-shi.

Parts of Nagoya-shi's Atsuta-ku, Kita-ku, Nakagawa-ku, Nakamura-ku, Nishi-ku, Higashi-ku, Mizuho-ku, Minami-ku, Moriyama-ku, Obu-shi, Owariasahi-shi, Tokai-shi, Nishikasugai-gun Toyoyama-cho

After this area expansion, SKY PerfecTV! HIKARI service area from June 1, 2008 covers all areas in Nagoya-shi, Kiyosu-shi, Ama-gun's Ooharu-cho, shippo-cho, Jimokuji-cho, Miwa-cho and Nishikasugai-gun Haruhi-Cho and parts of Obu-shi, Owariasahi-shi, Tokai-shi, Toyoake-shi, Nisshin-shi, Aichi-gun Togo-cho and Nishikasugai-gun Toyoyama-cho in Aichi Prefecture.
