## **Notice Regarding Dissolution of SKY Perfect Mobile, Inc.**

SKY Perfect JSAT Holdings Inc. (Head Office: Minato-ku, Tokyo; President and CEO: Masanori Akiyama; "SKY Perfect JSAT Holdings") has announced that at a Board of Directors meeting held today, it has decided that wholly owned subsidiary SKY Perfect JSAT Corporation (Head Office: Minato-ku, Tokyo; President and CEO: Masanori Akiyama; "SKY Perfect JSAT") will dissolve its subsidiary SKY Perfect Mobile, Inc. (Head Office: Minato-ku, Tokyo; President and CEO: Shuhei Yamaura; "SKY Perfect Mobile").

In June 2005, SKY Perfect Mobile commenced operations as an operating company engaged in content distribution for mobile phones. On January 1, 2008 SKY Perfect Mobile was converted into a wholly owned subsidiary of SKY Perfect JSAT to promote flexible business development in the mobile communications field. Because SKY Perfect Mobile's operations were subsequently transferred to SKY Perfect JSAT, SKY Perfect JSAT Holdings has decided to dissolve SKY Perfect Mobile in August 2010 (planned).
