I would like to express my thanks to those who kept controlling satellites despite the damage to buildings, etc. due to East Japan Great Earthquake, the staff of Customer Center for SKY PerfecTV! for working hard although it became impossible to use some floors, and all of the people who assist the above staff and support our routine work. Anti-disaster institutions, etc. still use our communication satellites for post-disaster restoration. I would like you to continue swift response. In addition, we would like to make discussions how we can support the customers suffering from the disaster from their viewpoint.

As for our policy for this fiscal year, we will keep aiming to increase new subscribers to mainly "SKY PerfecTV! e2" in our multichannel pay TV business. This year, the transition from analog to digital broadcasting will be fully completed, and digital TV sets that can receive the three TV signals will spread. In October, the new BS broadcasting will be started. It is expected that many citizens will be aware of multichannel broadcasting this year. By utilizing this chance, we hope to enable customers to enjoy the three SKY PerfecTV! services according their lifestyles. As for the satellite business, we would like to maintain or improve the relations with long-term subscribers, such as governmental offices, and cultivate the satellite market that is growing especially in Asia and Oceania, with the spirit of going overseas actively. We aim to become a "sturdy" organization. With limited managerial resources, our company must be able to review all of our businesses deeply, and gain profits under any circumstances and prepare for the future, no matter how our society is unclear and the business environment is uncertain.
