SKY Perfect JSAT is proactively forging ahead with establishing high-definition broadcasting for our SKY Perfect Premium Service. We will update for this service from MPEG-2 to H.264 our broadcasting format in order to provide an even better viewing environment for our customers. The schedule for terminating the standard-definition format by MPEG-2 is provided below.

■ Channels for which broadcasting will end: SKY Perfect Premium Service

Channels in the 100s, 200s, 300s and 700s, and Ch.900 to Ch.917 Excluding [Better life] on channel 216, [Select Shopping Ch.217] on channel 217, [Shop Channel] on Ch.220, and [QVC] on Ch.222.

■ Date of Channel Termination: May 31, 2014 (Saturday)

While the above-mentioned standard-definition broadcasts by MPEG-2 will be terminated, the same programs will continue to be broadcast in high-vision on channels in the 500s, 600s and Ch.942 to Ch.975. (Including standard-definition broadcasts by H.264) You can continue to enjoy these programs by replacing your tuner with the Premium Service tuner and renewing your contract. The music radio programs on channels in the 400s will continue to be broadcast on the same channels.

We will keep you informed of details via the member magazine and DMs, etc. in the future.
