SKY Perfect JSAT Corporation (Head Office: Minato-ku, Tokyo; Representative Director, President& Chief Executive Officer: Shinji Takada) announced the number of subscribers *1 as of the end of January 2013.

As to total for SKY PerfecTV!, the number of new subscribers was 46,903, the number of re-registered subscribers was 3,732 and the number of churn was 61,977. The number of new subscribers and re-registered subscribers decreased, and the number of churn increased from the previous month. Consequently, net decrease was 11,342.

The number of subscribers' shifts from the SD to the HD services in Premium Service was as healthy as 20,025.
