## Number of Subscribers as of the end of February 2013

SKY Perfect JSAT Corporation (Head Office: Minato-ku, Tokyo; Representative Director, President& Chief Executive Officer: Shinji Takada) announced the number of subscribers \*1 as of the end of February 2013.

As to total for SKY PerfecTV!, the number of new subscribers was 54,315, the number of re-registered subscribers was 10,796 and the number of churn was 58,509. The number of new subscribers and re-registered subscribers increased due to the 'SKY PerfecTV! free broadcasting for the 10-days period' from February 2. Consequently, net increase was 6,602. The number of new subscribers of SKY PerfecTV! (former SKY PerfecTV! e2) was 49,501.and it was a high record on a single month basis in February.

The number of subscribers' shifts from Standard definition to High definition in Premium Service reached 70,753 and it also hit a high record.
