# Notice of Appointment of Executives and Reorganization of Subsidiary

SKY Perfect JSAT Holdings Inc. (Head Office: Minato-ku, Tokyo; Representative Director, President: Eiichi Yonekura) held a meeting of its Board of Directors on May 8, 2019 and informally decided on the appointment of directors and corporate auditors, which will be in effect from June 21, 2019.

SKY Perfect JSAT Corporation (Head Office: Minato-ku, Tokyo; Representative Director, President & Chief Executive Officer; Eiichi Yonekura), a wholly owned subsidiary of SKY Perfect JSAT Holdings Inc., also held a meeting of its Board of Directors on May 8, 2019 and, in effect from June 21, 2019, informally appointed its directors while officially appointing its executive officers. The Board also officially agreed on its structural reorganization, which will be in effect from July 1, 2019.

These appointments for both SKY Perfect JSAT Holdings Inc. and SKY Perfect JSAT Corporation are subject to the approval at the General Meeting of Shareholders scheduled on June 21, 2019, and the position of the directors will be officially resolved at the board meeting held immediately after the GMS.

2. Reorganization of SKY Perfect JSAT Corporation (Effective July 1, 2019)

The following organizational changes (reorganization of groups and high-level organizations; new establishment of unit management plans) will be made on July 1 of this year.

- (1) In order to improve profit consciousness, increase the speed of decision-making and respond to business expansion in the Space Business and the Media Business, we will abolish the Engineering & Operations Unit, rename the Broadcasting Engineering Group as the Media Engineering Group and incorporate it into the Media Business Unit, and rename the Satellite Planning & Operations Group as the Space Engineering Group and incorporate it into the Space Business Unit.
- (2) We will establish new Planning & Administration Div. in the Space Business Unit and Media Business Unit in order to oversee budgeting and personnel in the units. In conjunction, we will abolish the Business Strategy Division and Planning & Coordination Division in Media Business Unit and Business Strategy Division in Space Business Unit.

(3) We will separate the Corporate Planning & Administration Unit into the corporate planning & strategy function and the corporate administration function, and then establish the Corporate Planning & Strategy Unit and the Corporate Administration Unit for each function. In conjunction, we will abolish the Corporate Planning & Strategy Group and the Corporate Services Group.


